Please be advised that the Ypsilanti Community Utilities Authority (YCUA) has scheduled a public hearing for Thursday, May 20, 2021 at 7:00 p.m. to discuss proposed wastewater system improvements projects for the purpose of receiving comments from interested persons. The purpose of the improvements is to increase the efficiency of the YCUA wastewater collection and treatment system within both the City of Ypsilanti and the Charter Township of Ypsilanti. YCUA proposes to fund these improvements by using Clean Water State Revolving Fund loans. Copies of the preliminary project plan detailing the proposed improvements, including analysis of impacts and estimated costs to customers, will be available for public inspection after April 20, 2021 on the YCUA website at www.ycua.org. Written comments received through May 20, 2021 will be entered into the public hearing record.
