PLEASE BE ADVISED THAT THE YPSILANTI COMMUNITY UTILITIES AUTHORITY (YCUA) HAS BEEN SCHEDULED A PUBLIC HEARING FOR WEDNESDAY, JUNE 15, 2022, AT 7:00 P.M. LOCAL TIME TO DISCUSS PROPOSED WATER SUPPLY IMPROVEMENTS IN BOTH THE CITY OF YPSILANTI AND THE CHARTER TOWNSHIP OF YPSILANTI. THE MEETING WILL BE HELD IN THE BOARD ROOM AT THE YCUA ADMINISTRATION BUILDING, 2777 STATE ROAD, YPSILANTI.

The improvements are proposed to increase the reliability of the YCUA water supply system within the City of Ypsilanti and the Charter Township of Ypsilanti. YCUA proposes to fund these improvements by using Drinking Water Revolving Fund (DWRf) loans. Copies of the preliminary DWRf Project Plan will be available for public inspection starting May 13, 2022, at the YCUA Engineering Department, located in the Eldon P. Ahles Administration Building, 2777 State Road, Ypsilanti, Michigan or on the YCUA website at www.ycua.org. Written comments received through June 15, 2022, will be entered into the public hearing record and should be directed to Scott Westover, Engineering Manager, at 2777 State Road, Ypsilanti, Michigan, 48198-9112 or via electronic mail at swestover@ycua.org.
