

ORDINANCE NO. 1381

An ordinance to amend Chapter 106, Article V, Section 106-454(b) of the Code of Ordinances to adjust water service rates.

BE IT ORDAINED BY THE CITY OF YPSILANTI, that:

Chapter 106, Article V, Section 106-454(b) of the Code of Ordinances shall be amended as follows:

(b) For all billings rendered prior to October 21, 2021, existing water service rates shall prevail. For all billings rendered on or after October 21, 2021, water service rates shall be as follows, for each bimonthly (two-month) period:

(1) Readiness-to-serve rates based on size of meter:

Meter Size (inch)	Water Rate
5/8-3/4	\$ 20.00
1	\$ 50.00
1-1/2	\$ 99.99
2	\$ 159.98
3	\$ 499.93
4	\$ 999.87
6	\$ 1,999.74
8	\$ 3,499.54
10	\$ 5,499.28
12	\$ 6,499.15

(2) Commodity rate: \$5.72 per 100 cubic feet

BE IT ORDAINED BY THE CITY OF YPSILANTI, that:

Chapter 106, Article V, Section 106-454(a) of the Code of Ordinances shall be amended as follows:

(b) For all billings rendered prior to October 21, 2021, existing sewage disposal rates shall prevail. For all billings rendered on or after October 21, 2021, sewage disposal rates shall be as follows for each bimonthly (two-month) period:

(1) Readiness-to-serve rates based on size of meter:

Meter Size (inch)	Sewage Rate
5/8-3/4	\$ 17.59
1	\$ 43.96
1-1/2	\$ 87.90
2	\$ 140.65
3	\$ 439.54
4	\$ 879.08
6	\$ 1,758.16
8	\$ 3,076.78
10	\$ 4,834.93
12	\$ 5,714.02

(2) Commodity rate: \$3.14 per 100 cubic feet


